

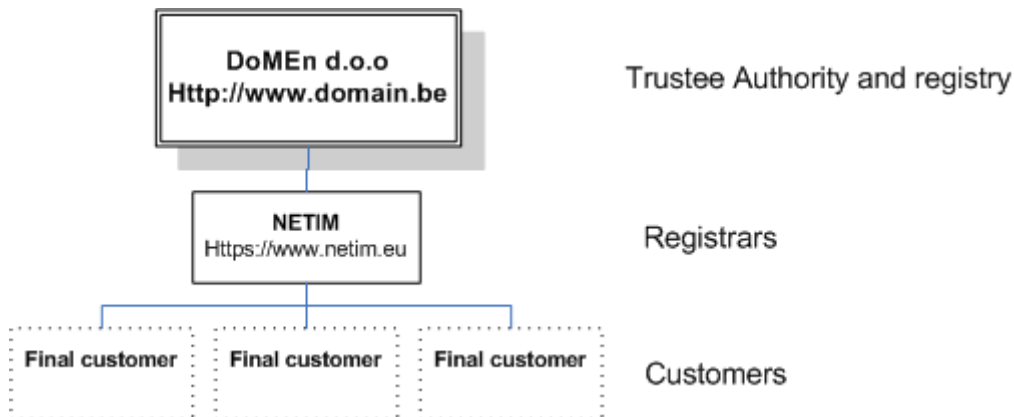
ANNEXE ME - SPECIAL TERMS AND CONDITIONS FOR THE ccTLD .ME

In addition to the general terms and conditions CG-ND, the registration or use of a Domain Name in a .ME Extension implies the acceptance and respect of these special terms and conditions CP-ND-ME.

All terms employed in these special terms and conditions beginning with a capital letter are to be interpreted in compliance with the definition assigned to them in the general terms and conditions CG-ND.

SECTION ME.1: TRUSTEE AUTHORITY AND REGISTRY

ME.1.1 The following diagram shows the different operators and the naming system for this Extension



ME.1.2 NETIM® is accredited by **doME n d.o.o** and act as an official registrar for the management of .ME domain names. See <http://www.domain.me/index.php?page=22>

SECTION ME.2: REGISTRATION REGULATIONS

ME.2.1 Domain Names under this Extension are registered on a "*first come, first served*" basis

ME.2.2 The Client declares and guarantees that the Domain Name respects the rights of third-parties, currently applicable laws as well as the regulations specific to the Extension, which can be consulted at the following addresses:

The Client agrees to have read and accepted these contractual documents (the "NICME Regulations" below) which link him to the Registry. These special terms and conditions do not substitute these regulations which are integrated by means of a hyperlink.

ME.2.3 All disputes relative to the choice and to the registration of Domain Names in this Extension are subject to different regulations and procedures for the resolution of disputes, detailed below in SECTION ME.5, to which the Client accepts to comply when registering the Domain Name.

SECTION ME.3: TRANSFER REGULATIONS

ME.3.1 The Client initiates through the intermediary of NETIM® a transfer request for a Domain Name in .ME from another registrar to NETIM® (also referred to as "incoming transfer"), according to the procedure specified on our site, and in compliance with NICME Regulations:

ME.3.2 The effective processing of the transfer is not immediate and implies the intervention of several actors. It does not depend exclusively on NETIM® and is particularly subject to the following restrictions:

- i) no transfer can intervene within sixty (60) days after the initial creation of the Domain
- ii) no transfer can intervene within sixty (60) days after the last transfer of the Domain
- iii) the Domain Name's status may be such that it doesn't prohibit the transfer (for example, when in "Transfer Prohibited" status).
- iv) the Client must provide the authorisation code (also referred to as "Auth-ID") provided by the previous Registrar; If the Client refuses or does not explicitly authorise the requested transfer in compliance with these procedures, the transfer shall fail without compensation or refund from NETIM®
- v) the previous Registrar may oppose the transfer of the Domain Name to NETIM®, for reasons which it must justify

ME.3.3 In the context of a transfer of a Domain Name to another Registrar (also referred to as "outgoing transfer"), the authorisation codes can be obtained in the Manager and is sent by electronic mail to the Client's email address.

SECTION ME.4: EXPIRY / RESTORATION REGULATIONS

ME.4.1 When the Domain Name's expiry date has passed, and failing prior renewal by the Client, the Domain Name shall be frozen and disabled for a period of thirty (30) calendar days during which all NETIM®'s associated services shall not be available. The Domain Name shall be referred to as in "HOLD" status

ME.4.2 Any Domain Name in "HOLD" status can be renewed under the same conditions as a simple renewal. Once payment of the price in full has been received by NETIM®, the Domain Name and its associated services shall be re-activated for the new chosen duration starting from the previous expiry date. Nevertheless, the re-activation process may take several days to propagate across the Internet.

ME.4.3 If the Client has not renewed the Domain Name by the end of the freeze period, the Domain Name shall be destroyed by NETIM®.

ME.4.4 If a Domain Name has been destroyed since under than thirty (30) calendar days, it can be restored subject to the following conditions and procedures, and depending on the details provided to NETIM® when carrying out said procedures:

- i) the restoration is only technically possible during this "buy-back" period (depending on the Registry: "Redemption Period" or "Pending Delete Restorable") which is the thirty (30) day period between the destruction of the Domain Name by NETIM® and its destruction by the Registry
- ii) payment for the restoration must be made seven (7) days before the destruction of the Domain Name by the Registry, to enable NETIM® to carry out the operation within the time limit. Failing this, it shall not be possible to restore the Domain Name and NETIM® cannot be held responsible on these grounds.
- iii) the restoration procedure restores the domain's previous parameters (personal and technical information) and extends by one (1) year the duration of the Domain Name's registration starting from the previous expiry date.

SECTION ME.5: MANAGEMENT OF DISPUTES

ME.5.1 NICME prescribes specific regulations and an alternative procedure for settling differences complemented by the "policy for settling disputes", relative to Domain Names in .ME, consultable at the following address:

ME.5.2 The Client agrees to have acknowledged and undertakes to respect these principles and regulations ("UDRP Regulations' below), integrated by means of a hyperlink to these special terms and conditions.

ME.5.3 In application of these UDRP Regulations, the Client accepts that any disputes concerning its Domain Name in .ME may be subject to these regulations

SECTION ME.6: CONTRACTUAL AMENDMENTS FOR SPECIAL TERMS AND CONDITIONS

ME.6.1 Regulation laid down by the Trustee Authority and the Registry are subject to change. These changes, linked to the naming system for .ME extensions are imposed by the Registry in charge of this Extension and represent changes that are not beyond NETIM®'s control.
